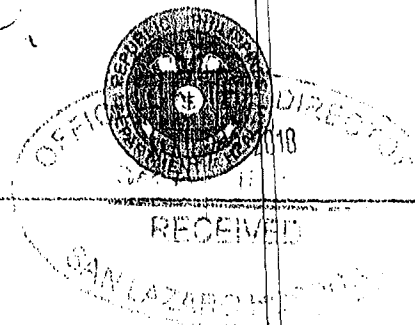

Direct contracting may be resorted to by concerned Procuring Entities by those sold by an exclusive dealer or manufacturer which does not have sub-dealers selling at lower prices and for which no suitable substitute can be obtained at more advantageous terms to the GoP pursuant to RULE XVI of the 2016 Revised IRR of RA 9184 and to submit the recommendation to the Officer In-Charge for approval.

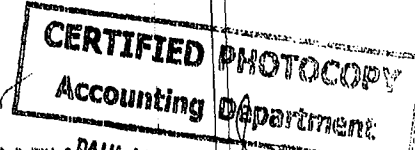
