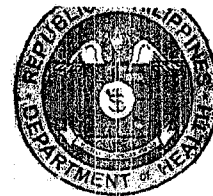

RECOMMENDING AWARD FOR THE NEGOTIATED PROCUREMENT: LEASE OF VENUE FOR THE "MANAGEMENT REVIEW"

WHEREAS, the San Lazaro Hospital, through its Bids and Awards Committee, adheres to the general policy that procurement of goods shall be competitive and transparent; and therefore shall undergo competitive bidding except as provided in Rule XVI of the 2016 Revised IRR of RA 9184;

WHEREAS, BAC Resolution No. AMP-081 s. 2019: **RECOMMENDING ALTERNATIVE METHOD OF PROCUREMENT OF NEGOTIATED PROCUREMENT: LEASE OF VENUE FOR THE "MANAGEMENT REVIEW"** was issued last July 23, 2019;
