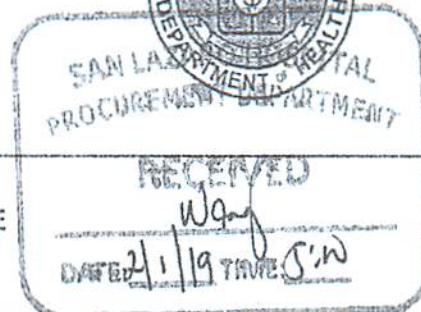

DECLARATION OF 2ND FAILURE OF BIDDING FOR THE PROCUREMENT OF GOODS FOR THE FOLLOWING ITEMS: A. DIETARY FOODSTUFF AND SUPPLIES, B. DENTAL MATERIALS AND SUPPLIES AND C. ENGINEERING/MAINTENANCE SUPPLIES;

WHEREAS, the San Lazaro Hospital, through its Bids and Awards Committee, posted an Invitation to Bid No. 2018-014: Procurement of Goods on November 21, 2018 at PhilGEPS website and in other conspicuous places in the hospital and other government hospitals;

WHEREAS, on November 29, 2018, a Pre-Bid Conference was conducted on the said advertisement;

WHEREAS, on October 30, 2018, BAC Resolution No. PB-005-A s. 2018 was issued declaring first bid failure for: A. Dietary Foodstuff and Supplies, B. Dental Materials and Supplies and C. Engineering/Maintenance Supplies;

WHEREAS, Section 35.1(a) of the 2016 Revised IRR of RA 9184 provides that: "the BAC shall declare the bidding failure when no bids are received";

WHEREAS, Section 35.2 of the same Act provides that: "In order to determine the reason for the failed bidding, the BAC shall conduct a mandatory review and evaluation of the terms, conditions, and specifications in the Bidding Documents, including its cost estimates";

WHEREAS, Section 35.5 of the same Act provides that: "Should there occur a second failure of bidding, the Procuring Entity may resort to negotiated procurement, as provided for in Section 53.1 of this IRR";


WHEREAS, after the opening of bids, a mandatory review together with the TWG and End-Users were conducted. The End Users requested for revision of their specifications on some items, if necessary, subject for approval;

NOW THEREFORE, We, the members of the Bids and Awards Committee, hereby RESOLVE as it is RESOLVED:

1. To recommend the approval of the declaration of 2ND failure of bidding for the procurement of the said items.
2. To recommend the abovementioned items under Categories: **A. Dietary Foodstuff and Supplies, B. Dental Materials and Supplies, and C. Engineering/Maintenance Supplies** for **Negotiated Procurement: Two Failed Biddings** under **Section 53.1**;
3. To submit these recommendations to the Medical Center Chief II for approval.
