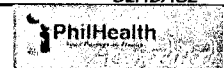
WHEREAS, on October 20, 2020, Notice of Post Qualification was sent to the Single Calculated bidder;

3. To submit this recommendation to the Medical Center Chief II for approval.




