**KNOW ALL MEN BY THESE PRESENTS:**

**CRN 2020-10-34**

This contract is entered by:

**SAN LAZARO HOSPITAL (SLH)**, a government hospital under the Department of Health, with principal office address at Quiricada Sta. Cruz, Manila, represented by **EDMUNDO B. LOPEZ, MD, MPH, MHA**, Medical Center Chief II, herein referred to as the **"First Party"**;

and

The **JM TRAVEL & TOURS TICKETING OFFICE & RENT-A VAN CORP**, a private entity organized in accordance with the laws of the Philippines with business address at U-4-10 Ferosa Bldg.2040 San Juan cor. Donada St. Brgy 037 Pasay City, represented by **Daniel Paragatos Romero**, Corporate Secretary herein referred to as the **"Second Party"**;

Collectively referred to as the parties.

Witnesseth that:

**WHEREAS**, the **Second Party** is engaged in the business of providing transportation services;


**WHEREAS**, on March 8, 2020, pursuant to the recommendation of the DOH, President Rodrigo Duterte has agreed to issue a declaration of a State of Public Health Emergency through Proclamation No.922. The said declaration would capacitate government agencies and LGUs to immediately act to prevent loss of life, utilize appropriate resources to implement urgent and critical measure to contain or prevent the further spread of COVID-19, mitigate its effect and impact to the community, and prevent serious disruption of the functioning of the government and the community;


**WHEREAS**, according to BAC Resolution No. AMP-003 s. 2020 dated October 13, 2020, the shuttle/van rental for the above cited activity will be procured through Section 53.2 of the IRR of RA 9184;


**WHEREAS**, Section 53.2 of the IRR of Republic Act 9184 allows Emergency Cases of Transportation Services under Negotiation Procurement;

**WHEREAS**, the **First Party** awarded the **Second Party** after the required canvass was conducted under the issued BAC Resolution No. AMP-003-A s. 2020 dated October 15, 2020;



2. The **First Party** shall pay the total amount of **Six Hundred Sixteen Thousand Pesos (Php 616,000.00)** for the package cost of Three Thousand Five Hundred Pesos (Php 3,500.00) per trip with maximum of 8 pax per van, for the duration of Twenty Two (22) days from October 1, 2020 to October 30, 2020, excluding Saturday and Sunday.
3. **Second Party** shall discharge its obligations to the **First Party** with extraordinary diligence and skills required by law including, but not limited to: (a) providing roadworthy and well-maintained vehicle(s); (b) designating duly licensed and skilled driver(s) to operate the same; and, (c) to refrain from sub-contracting ANY of its obligations in this contract. **In case of breach, Second Party shall be prosecuted to the fullest extent of the law.**
4. Full payment of the total package cost shall be settled after completion of the services and upon submission of a billing statement, subject to the policy of the **First Party** in processing of payments, and government accounting and auditing rules. The contract price under the terms of this contract shall be charged to SAA 2020-06-1118.
5. Both parties agree that they shall each protect and maintain the confidentiality of all personal information, in accordance with applicable governing laws. Further, the Parties agree that the activities covered by this Agreement are confidential in nature, and the Parties respective employees, personnel, agents and representatives shall not, during the term of this agreement and after its termination, disclose to or furnish any person or entity, or use for its own benefit, or cause the publication or disclosure of, any confidential information which has come or may come to its knowledge in the course of the implementation of this Agreement, or in the course of their stay within their places of assignment, and as an incident to this Agreement.
