RESOLUTION ON THE MOTION FOR RECONSIDERATION FILED BY RBGM MEDICAL EXPRESS SALES INC., SHILOHMED CORP., VARIANCE TRADING CORP., PRIME ESSENTIALS MANUFACTURING AND TRADING COMPANY AND EGMJ TRADING

WHEREAS, the Bids and Award Committee (BAC) was created in accordance to the R.A 9184, ensuring transparency in the procurement process and in the implementation of procurement contracts with the end view of guaranteeing that contracts are awarded pursuant to the provision of Republic Act 9184 and its Implementing Rules and Regulation, and that all procurement are conducted strictly according to specification.

WHEREAS, on January 9, 2020, the invitation to Bid for **ITB-2020-001**: Public Bidding for the Medical Supplies was posted on the website of the Procuring Entity, the PhilGEPS, and any conspicuous place reserved for this purpose in the premises of the Procuring Entity concerned, as certified by the head of the BAC Secretariat of the Procuring Entity concerned.

WHEREAS, on January 15, 2020 a Pre-Bid Conference was conducted with twenty (20) prospective bidders in attendance, wherein a Pre-Bid Conference must be held for contracts with ABCs of at least One Million Pesos (P 1 Million) and must be conducted at least twelve (12) calendar days before the deadline for the submission and receipt of bids, but not earlier than seven (7) calendar days from the PhilGEPS posting of the ITB. (2016 IRR, Section 22.2).

WHEREAS, Section 30. Rule IX of the revised IRR of the **RA No. 9184** known as Government Procurement Reform Act requires that the preliminary examination of bids be conducted by merely checking for the presence or absence of documentary requirement using a non-discretionary "pass/fail". If a bidder submits the required documents, it shall be rated "passed" for the particular requirements. In this regard, bids that fail to include any requirements or are incomplete or patently insufficient shall be considered as "failed".

WHEREAS, on February 5, 2020, only eighteen (18) prospective bidders submitted its bids before the deadline and simultaneous, the Bids and Award Committee (BAC)-1 conducted the opening of bids with the presence of Technical Working Group (TWG). After evaluation and validation of required number of envelopes for Envelope-A (Eligibility and Technical components), the Bids and Award Committee (BAC)-1 declared the bidders **RBGM MEDICAL EXPRESS SALES INC., SHILOHMED CORP., VARIANCE TRADING CORP., PRIME ESSENTIALS MANUFACTURING AND TRADING COMPANY AND EGMJ TRADING** as "**DISQUALIFIED**" through verbal notification for failure to comply in accordance with the rules in preparing the set of envelopes, as required copy of COA and accounting apart from the original documents dedicated for BAC reference. Thus, Envelope-B 2 containing the bidders financial proposal was not opened.

WHEREAS, Section 55.1. "Decisions of the BAC at any stage of the procurement process may be questioned by filing a request for reconsideration within the three (3) calendar days upon receipt of written notice or upon verbal notification. The BAC shall decide on the request for reconsideration



within seven (7) calendar days from receipt thereof. The bidder shall not be allowed to submit additional documents to correct any defects in the bid submitted."

WHEREAS, on February 6, 2020, the **RBGM MEDICAL EXPRESS SALES INC** and **EGMJ TRADING** submitted a Motion for Reconsideration seeking for the reversal of the disqualification decision of the Bids and Award Committee (BAC)-1, while on February 7, 2020, the **SHILOHMED CORP., VARIANCE TRADING CORP., PRIME ESSENTIALS MANUFACTURING** and **TRADING COMPANY AND EGMJ TRADING** requested the same motion.

WHEREAS, the Bids and Award Committee (BAC)-1 has convened last February 7, 2020 and discussed the request for consideration of the five (5) bidders and the grounds relied upon by the bidders on their motion.

WHEREAS, the Bids and Award Committee (BAC)-1 upon checking, confirming and reconciling the rules and bidding documents for the project, has unanimously agreed to grant the motion made by the five (5) suppliers. Thus, response within the prescription time was made through electronic email to the five (5) suppliers (**RBGM MEDICAL EXPRESS SALES INC., SHILOHMED CORP., VARIANCE TRADING CORP., PRIME ESSENTIALS MANUFACTURING AND TRADING COMPANY AND EGMJ TRADING**).

WHEREAS, the Bids and Award Committee (BAC)-1 upon deliberation, has unanimously made a decision as to the definite date and place for the submission and opening of bids: **ITB-2020-001** for the category of **Medical Supplies** and **Vehicular Parts** will be on **February 19, 2020, Training Room, Pavillion V** at **9:30 AM** of this institution.



