SUBJECT: Advisory on PBB 2017 Rating and Ranking

All provisions under DO 2016-0273 "Guidelines on the Rating and Ranking of the Department of Health Units for the FY 2016 Performance-Based Bonus (PBB)" shall stand in effect with the addition of the following clauses:

1. Performance Targets and Accomplishments

FY 2017 targets and accomplishments shall be measured in rating and ranking offices as well as in identifying eligible personnel for PBB 2017.

2. Delivery Units per PBB Category

Office of the Secretary and Cluster Offices shall include both the current and former Secretaries, Undersecretaries and Assistant Secretaries who have served in the said offices in FY 2017 which comprises the following:
